FACULTY GUIDELINES FOR GIVING STUDENTS GRADING RESPONSIBILITIES

These guidelines are not meant to supersede the professional judgment of faculty in particular situations.

In all situations where students have grading responsibilities, the instructor for the course should make these students' roles known to the class clearly and explicitly at the beginning of the term. This should include (but need not be limited to) a discussion of the following three (3) points:

1. Giving student workers or teaching apprentices responsibility for grading true-false or multiple-choice tests and assignments will not ordinarily raise any concerns.
 2. In situations where student workers or teaching apprentices have responsibility for reading essay tests, papers, etc., the instructor should make the ultimate determination of the grade.
 3. In all situations where students have grading responsibilities, the instructor should ensure that students responsible for grading do not distribute, reproduce, or misplace tests and assignments entrusted to them.

GUIDELINES FOR APPRENTICE TEACHERS AND OTHER SITUATIONS WHERE STUDENTS ARE INVOLVED IN CLASSROOM INSTRUCTION

1. In most cases, it is appropriate for apprentice teachers to be associated with introductory (1000-level) courses rather than advanced courses.
 2. The *Faculty Guidelines* for giving students grading responsibilities should be followed. These guidelines are not meant to preclude the opportunity for students to learn how to evaluate course work and examinations.
 3. In situations where the teaching apprentice gives a lecture or presentation to the class, the instructor should be present in order to serve as a resource for both the class and the apprentice.
 4. The instructor for any course with a teaching apprentice should make the apprentice's role known to the class clearly and explicitly at the beginning of the term.
