Participation in internships grew modestly from 2004-2005 to 2005-2006 with 293 students completing internships in 2005-2006 compared to 286 in 2004-2005. This increase may in part be due internship outreach to sophomores and juniors in 2005-2006. In addition to an aggressive outreach program, the internship program staff emphasized the importance of submitting internship paperwork in a timely manner and saw fewer late LEAD Learning Agreements as a result. This year, we also began recognizing internship site supervisors with a letter and certificate of recognition through the mail. Due to a data coding error, in the past the difference between individual internships and practicum seminar internships were inaccurate.\* This year's report reflects a more accurate number. In this year's report we have also included a breakdown of number of internships by faculty supervisor.
