The Yellow Ribbon GI Education Enhancement Program is a provision of the Post-9/11 Veterans Education Assistance Act of 2008. Under this program, Hamline University has entered into an agreement with the Department of Veterans Affairs to fund tuition expenses that exceed \$20,235.02 for student-veterans who are eligible for 100% of Chapter 33 benefits. Hamline University will award institutional aid of a predetermined maximum dollar amount to a set number of students.

To receive benefits under the Yellow Ribbon Program you must:

1. Apply for the Post 9/11 GI Bill at <http://www.gibill.va.gov>
2. Submit this application to Hamline’s Office of Financial Aid, along with a copy of both your DD-214 and Certificate of Eligibility issued by the Department of Veterans Affairs

STATEMENT OF ACKNOWLEDGMENT

Please read carefully before signing below:

- I understand that the Department of Veterans Affairs formally establishes eligibility for the Post-9/11 GI Bill and that participation in the Yellow Ribbon Program is contingent on VA approval of education benefits at 100% eligibility.
- I believe I am 100% eligible for the Post-9/11 GI Bill based on the following qualifications set and determined by the Department of Veterans Affairs:
 - I served an aggregate period of at least 36 months on active duty after September 10, 2001, or
 - I was honorably discharged from active duty for a service-related disability, and I served 30 continuous days after September 10, 2001, or
 - I am a dependent eligible for Transfer of Entitlement under the Post-9/11 GI Bill.
- I understand that this application will be considered **incomplete** until both my **DD-214** and **Certificate of Eligibility** provided to me by the Department of Veterans Affairs are submitted to Hamline’s Financial Aid Office. (Applications may be submitted prior to submitting a DD-214 and Certificate of Eligibility)
- I am currently an enrolled and degree seeking Hamline University student.
- I acknowledge that the Yellow Ribbon Program funds are distributed on a first-come, first-served basis measured from the date that this application and all required documentation is received.
- I understand that submitting this form does not guarantee my admittance into the Yellow Ribbon Program.
- I understand that Yellow Ribbon funding, with its corresponding match from VA, may replace any previously awarded institutional grants and/or scholarships.
- I understand that Hamline University is not required to continue making Yellow Ribbon Program contributions if I am not in good academic standing, if I have a break in attendance, or if Hamline University revises or does not renew the Yellow Ribbon agreement with Veterans Affairs for the following academic year.
