

American Rescue Plan (ARP) - Student Emergency Assistance Grants

January - March 2022 Report

This report contains information that is required by the U.S. Department of Education (Ed).

Hamline's President, Fayneese Miller, signed and the University returned to Ed the Certification and Agreement document with the assurance that the University has and will expend awarded funds as designated to provide Emergency Financial Aid Grants to Students.

- Subsequently, Hamline University received an award from Ed on April 22, 2020, in the amount of \$1,285,114 in accordance with the **Coronavirus Aid, Relief, and Economic Security Act (CARES)** to provide emergency financial aid grants to students. These funds have been fully distributed to 1,360 students.
- In addition, Hamline received a supplemental award from Ed on December 27, 2020, in the amount of \$1,285,114 in accordance with the **Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA)** to provide additional emergency financial aid grants to students. These funds have been fully distributed to 852 students.
- Finally, Hamline received a second supplemental award from Ed on May 19, 2021, in the amount of \$3,485,600 in accordance with the **American Rescue Plan (ARP)** to provide further emergency financial aid grants to students.
- Therefore, Hamline University has received \$6,055,828 in total from Ed to provide emergency financial aid grants to students.

Regarding American Rescue Plan (ARP) funds for the quarter ending March 31, 2022, the total number of students at Hamline determined to meet the institution's standards for eligibility to receive an emergency financial aid grant was 3,139, and 826 of these students received emergency grants totaling \$1,307,224.

There have been two disbursements of emergency grants in the first quarter of 2022. The first disbursement provided grants to 16 undergraduate students who provided AY2022 FAFSA information after Fall 2021 HEERF emergency financial aid grants were distributed. These students demonstrated exceptional financial need based upon their expected family contribution (EFC). Three (3) additional students who provided documentation of a specific

emergency financial need were disbursed awards of \$1,000 each. This disbursement provided a total of \$27,791 to these 19 students.

The second disbursement this quarter provided grants to 819 current domestic undergraduate students, which included 12 of those from the disbursement earlier in the quarter. Each recipient demonstrated exceptional financial need based upon their current year expected family contribution (EFC) and enrollment percentage. The following table provides additional details regarding this disbursement.

Hamline has followed relevant federal guidelines in disbursing these Emergency Financial Aid grants, which total \$1,307,224, provided to 826 students. This is an average of \$1,583 per student recipient.
